

**FOREST RESOURCES DEVELOPMENT PROGRAM: PROJECTS PHASE II
2009-2010 (PMVRMF- VOLET II 2009-2010)**

Gatineau, february 10th 2009 - The CRÉO (Conférence régionale des élus de l'Outaouais) invites promoters interested in the protection and development of the forest resources to present, **no later than April 17th 2009**, their projects in the Forest Resources Development Program, Phase II.

The aim of this program is to support projects of a silvicultural, faunal, recreational, educational or environmental nature which stimulate economic and social development in the Outaouais. Consequently, this program is a means of promoting job creation and implicating the community in the management of diverse forest resources.

The financing of this program is provided by the Ministry of Natural Resources and Fauna of Québec, which disburses to the CRÉO a budgetary envelope drawn from the Forestry Fund. The CRÉO manages the funds in collaboration with the MRC Pontiac, the MRC Collines de l'Outaouais, the MRC Papineau and the MRC Vallée de la Gatineau.
